


Overview of U.S. Exports of 600-Series and 9x515 Items

U.S. exports of 600-Series and 9x515 items from October 15, 2013 to August 31, 2020 totaled 696,021 shipments¹ for approximately \$48.7 billion under both BIS and DDTC authorization.

U.S. Exports of 600-Series and 9x515 Items by Value


Effective Date to August 31, 2020

Effective Date to August 31, 2020



¹ Shipments are defined as exports being sent from one order party to one consignee located in a single country of destination on a single conveyance on the same day.

Of \$48.7 billion in U.S. exports of 600-Series and 9x515 items from October 15, 2013 to August 31, 2020, \$45.0 billion (92.5 % of the total) was shipped under BIS authorization; and \$3.7 billion (7.5%) was shipped under DDTC authorization².

U.S. Exports of 600-Series Items under BIS Jurisdiction

Of \$45.0 billion in U.S. exports under BIS jurisdiction from October 15, 2013 to August 31, 2020:

- \$35.3 billion were for 600-series items; and
- \$9.7 billion were for 9x515 items.

Of \$35.3 billion in U.S. exports under BIS jurisdiction for 600-series items, the top 3 destinations were Japan with \$6.1 billion (17.3% of the total value), Canada with \$3.5 billion (10.0%) and the United Kingdom with \$3.3 billion (9.3%).



9A610	Military aircraft and related commodities
9A619	Military gas turbine engines and related commodities
3A611	Military electronics
0A606	Ground vehicles and related commodities
7A611	Navigation and avionics equipment and, systems and "parts," "components," "accessories," and "attachments" "specially designed" therefor, "specially designed" for a military application that are not enumerated in any USML category or another "600 series" ECCN are controlled by ECCN 3A611.
9A604	Commodities related to launch vehicles, missiles, and rockets

Of \$35.3 billion in U.S. exports of 600-series items under BIS jurisdiction from October 15, 2013 to August 31, 2020, licensed exports totaled \$17.2 billion (48.8% of the total); STA totaled \$3.8 billion (12.3%); and RPL totaled \$3.5 billion (10.0%).

BIS License Exceptions:

STA: Strategic Trade Authorization

RPL: Servicing and replacement of parts and equipment

NLR: No License Required

GOV: Governments, international organizations, international inspections under the Chemical Weapons Convention, and the International Space Station

TMP: Temporary imports, exports, reexports, and transfers (in-country)

LVS: Shipments of limited value
