



## Analysis of U.S. Trade with the United Kingdom, 2022

### Summary

#### Imports and exports reported by U.S. Census Bureau<sup>1</sup>

In 2022, both U.S. exports to United Kingdom and imports from the United Kingdom continued to grow for a third year in a row. U.S. exports totaled \$76.2 billion, an increase of 23.6% (\$14.5 billion), and U.S. imports totaled \$64.0 billion, an increase of 13.7% (\$7.7 billion). The trade surplus was \$12.3 billion, increasing 127.0% (\$6.9 billion) from 2021.

In 2022, 3.7% of total U.S. global exports of \$2.1 trillion were exported to the United Kingdom and 2.0% of total U.S. imports of \$3.2 trillion from all countries were imported from the United Kingdom.

In 2022, \$2.5 billion of U.S. exports of Art, Collectors' Pieces, and Antiques to the United Kingdom represented 22.6% of U.S. global exports of those commodities.

In 2022, U.S. exports of Arms and Ammunition to the United Kingdom increased significantly from \$155.8 million in 2021 to \$205.4 million, an increase of 31.8%.

In 2022, \$13.5 billion of U.S. imports of Machinery and Mechanical Appliances from the United Kingdom constituted 1.5% of the total U.S. imports of those commodities.

#### BIS export data<sup>2</sup>

In 2022, U.S. exports to the United Kingdom shipped under a BIS license exception totaled \$1.1 billion, a decrease of 16.5% from \$1.3 billion in 2021.

In 2022, the top license exception utilized under the Export Administration Regulations (EAR) was Encryption Commodities, Software, and Technology (ENC). Exports made with an ENC license exception totaled \$559.6 million, accounting for 49.7% of exports to the United Kingdom made under license exceptions. This was followed by Strategic Trade Authorization (STA) (\$166.4 million; 14.8%), and Servicing and Replacement of Parts and Equipment (RPL) (\$126.2 million; 11.2%).

## Analysis of U.S. Trade with the United Kingdom, 2022

### BIS licensing data<sup>3</sup>

In 2022, the number of export license applications for the United Kingdom, excluding applications for deemed<sup>4</sup> exports, amounted to 5.5% of total applications worldwide.

In 2022, for applications involving commodities, software, and technology (excluding deemed exports of technology and source code to British nationals in the U.S. or made as deemed reexports in a third country), BIS reviewed 2,155 export license applications valued at \$6.7 billion for United Kingdom. Of these applications, BIS approved 1,984 applications for the United Kingdom valued at \$6.5 billion with an approval rate of 92.1%. BIS denied six license applications for the United Kingdom. The remainder were returned without action (RWA).

In 2022, BIS reviewed 25 applications for deemed exports involving British nationals, representing 1.7% of total deemed export applications worldwide. Twenty-four of these applications were approved and one was returned without action (an approval rate of 96.0%).

In 2022, the top approved Export Control Classification Numbers (ECCNs) on licenses for the United Kingdom were 9A610 for Military Aircraft and Related Commodities with 563 approvals, followed by 3A611 for Military Electronics with 287 approvals, and 9E610 for Technology Required for the “Development,” “Production,” Operation, Installation, Maintenance, Repair, Overhaul, or Refurbishing of Military Aircraft and Related Commodities with 204 approvals.

In 2022, the average processing time for applications involving the United Kingdom was 22 calendar days.



### I. Total U.S. trade in goods with the United Kingdom<sup>5</sup>

In 2022, both U.S. exports to the United Kingdom and imports from the United Kingdom continued to grow for a third year in a row. U.S. exports totaled \$76.2 billion, an increase of 23.6% (\$14.5 billion), and U.S. imports totaled \$64.0 billion, an increase of 13.7% (\$7.7 billion). The trade surplus was \$12.3 billion, increasing 127.0% (\$6.9 billion) from 2021.



In 2022, the level of U.S. exports to the United Kingdom and U.S. imports from the United Kingdom in goods, merchandise, and commodities as well as the trade surplus with the United Kingdom all exceeded the prior five-year average level by value (not adjusted for inflation).

## Analysis of U.S. Trade with the United Kingdom, 2022

In 2022, of \$76.2 billion in U.S. exports to the United Kingdom, the top commodity sectors were Oil, Minerals, Lime, and Cement (25.6% of the total exports to the country), Chemicals, Plastics, Rubber, and Leather Goods (14.4% of such total), and Stone, Glass, Metals, and Pearls (14.3% of such total).

In 2022, of \$64.0 billion in U.S. imports from the United Kingdom, the top commodity sectors were Machinery and Mechanical Appliances (21.1% of the total U.S imports from the country), Chemicals, Plastics, Rubber, and Leather Goods (19.5% of such total), and Transportation Equipment (16.5% of such total).

In 2022, 3.7% of total U.S. global exports of \$2.1 trillion were exported to the United Kingdom and 2.0% of total U.S. imports of \$3.2 trillion from all countries were imported from the United Kingdom.

### Exports

In 2022, \$2.5 billion of U.S. exports of Art, Collectors' Pieces, and Antiques to the United Kingdom represented 22.6% of U.S. global exports of those commodities. Additionally, \$10.9 billion of exports of Stone, Glass, Metals, and Pearls represented 10.3%, and \$19.5 billion of Oil, Minerals, Lime, and Cement represented 5.0% of U.S. global exports of those commodities.

### Imports

In 2022, \$2.0 billion of U.S. imports of Art, Collectors' Pieces, and Antiques from the United Kingdom represented 19.1% of U.S. global imports of those commodities. Additionally, \$279.6 million of U.S. imports of Arms and Ammunition from the United Kingdom constituted 6.0% of the total U.S. imports of those commodities. Additionally, \$10.5 billion of imports of transportation equipment from the United Kingdom represented 3.0% of total U.S. imports of those commodities.

### U.S. Exports to United Kingdom in Arms and Ammunition

In 2022, U.S. exports of arms and ammunition to United Kingdom increased significantly from \$155.8 million in 2021 to \$205.4 million, an increase of 31.8%.

### II. U.S. Exports to United Kingdom Subject to BIS Export Controls<sup>6</sup>

In 2022, of the \$76.2 billion<sup>7</sup> in U.S. exports to United Kingdom:

- \$417.2 million, or 0.5% of the total value, were exported under a BIS license;
- \$1.1 billion, or 1.5% of the total value, were exported under a BIS license exception;
- \$11.8 billion, or 15.5%, were exported under No License Required (NLR) reporting an ECCN<sup>8</sup>;
- \$25.2 million, or 0.03%, were exported under NLR for 600-series .y subparagraph items<sup>9</sup>;
- \$0.2 million, or 0.0003%, were exported under NLR for 0A501 .y subparagraph Firearms items.<sup>10</sup>

For comparison, globally:

- 0.4% of U.S. exports by dollar value were exported under a BIS license;
- 0.8% were exported under a BIS license exception;
- 9.6% of exports were exported under NLR reporting an ECCN;
- 0.02% of exports were exported under NLR for 600-series .y subparagraph items;
- 0.001% of exports were exported under NLR for 0A501 .y subparagraph Firearms items.





In 2022, U.S. exports to the United Kingdom made under a BIS license exception totaled \$1.1 billion, a decrease of 16.5% from \$1.3 billion in 2021.



In 2022, the top license exceptions, Encryption Commodities & Software (ENC), totaled at \$559.6 million (49.7% of all license exceptions for the United Kingdom), followed by Strategic Trade Authorization (STA), totaled at \$166.4 million (14.8%), and Servicing and replacement of parts and equipment (RPL), totaled at \$126.2 million (11.2%).





- STA: Strategic Trade Authorization

In 2022, U.S. exports to the United Kingdom shipped under BIS license exception ENC totaled \$559.6 million, a 6.4% decrease from \$597.7 million in 2021.



### III. BIS Licensing Involving the United Kingdom<sup>11</sup>

In 2022, the number of export license applications for the United Kingdom, excluding applications for deemed exports and reexports, amounted to 5.5% of total applications worldwide.


In 2022, for applications involving commodities, software, and technology (excluding deemed exports and reexports of technology and source code to British nationals in the U.S. or in a third country), BIS reviewed 2,155 export/re-export license applications valued at \$6.7 billion for the United Kingdom, compared to 39,045 applications worldwide valued at \$335.9 billion. BIS denied six license applications. BIS approved 1,984 applications valued at \$6.5 billion with an approval rate of 92.1%, compared to 34,068 approvals worldwide and valued at \$226.1 billion with an approval rate of 87.3%.

## Analysis of U.S. Trade with the United Kingdom, 2022



In 2022, BIS reviewed 25 applications for deemed exports or reexports involving British nationals, representing 1.7% of total deemed export or reexport applications worldwide. BIS approved 24 of these applications and returned one without action (an approval rate of 96.0%).

In the last five years, there were no denials for applications for deemed exports or reexports involving British nationals.

In 2022, the top approved ECCNs on licenses for the United Kingdom were 9A610 for Military Aircraft and Related Commodities with 563 approvals, followed by 3A611 for Military Electronics with 287 approvals, and 9E610 for Technology Required for the “Development,” “Production,” Operation, Installation, Maintenance, Repair, Overhaul, or Refurbishing of Military Aircraft and Related Commodities with 204 approvals.
